ISO 27001 is an internationally recognised and respected Information Security standard, based on a framework for implementing and maintaining an Information Security Management System (ISMS). It is one of the most popular standards for information security and is frequently used as a measure of security maturity by organisations undertaking supply chain due diligence. At the core of ISO 27001 is protecting the Confidentiality, Integrity and Availability (CIA) of data and systems.

Implementing ISO 27001 will demonstrate to your clients that you take information security seriously and your business is taking appropriate steps to both reduce and manage risks effectively.

Gap Analysis

Preparation

Stage 1 Audit

The stage 1 audit is completed by the certification body and will highlight areas, if any, that require further work to obtain full certification. CyberScale can help you identify a suitable certification body and will support the stage 1 audit with your team.

Remediation Support

Any areas requiring further considerations will be addressed and implemented in preparation for the Stage 2 audit.

Stage 2 Audit

The audit is completed by the certification body for ISO 27001 certification. Assuming successful, the auditor will put forward a recommendation for certification.

Ongoing support

Following your successful certification, CyberScale will assist you as required with your ongoing internal and surveillance audits, helping to ensure ongoing certification and continuous improvement in line with the **Plan - Do - Check - Act** principle of ISO 27001.
